## Corporate Giving Fund

Set aside charitable dollars in your Corporate Giving Fund in high earning years. Receive a charitable tax deduction in the year your business contributes to the Giving Fund, then give the dollars away when you are ready.



### A Corporate Giving Fund at the Foundation:

- Operates based on a standard agreement between you and the Foundation.
- Has no establishment fee and a very low administration cost.
- Provides report of charitable grants from your fund and the impact on the community, giving you information that you can share through your marketing and promotions.

### WHAT ARE THE MINIMUMS AND FEES?

A Corporate Giving Fund may be opened with as little as \$10,000.

Annual Administrative Fees.....1.5 -2.5%

Investment Management Fees.....Variable  
(0.6- 0.7%)
